Each Purchasing Group periodically receives by its Suppliers - generally monthly - data regarding Purchases of each of its Associates, for aggregation and analysis purposes, in order to verify their trend upon fixed objectives. Since there is no reference guideline, each supplier structures its own transmission file, preventing, in fact, the automation of data collection and aggregation process, and obliging the Group to "work by hand" with easily imaginable consequences.

Having a shared guideline available to organize such data is the basic element in order to automate the process for their uploading, aggregation and analysis.

The **PURCHASES RECORD LAYOUT**, prepared by comparing the different Purchasing Groups needs, and presented below, is aimed at indicating to Suppliers how to normalize the data related to their Sales (the Purchases for Associates); in case all the Suppliers will adopt the convention of a single trace, the activity of data collection, aggregation and analysis, by the Purchasing Groups, can be automated.

With regard to the methods for data transmission (automatically via FTP area or Drop Box), each Supplier will agree with the reference Group.
